Five tips to support the after-school 'meltdown'

Picture the scene: your child comes out of school and the teacher says they've behaved like the perfect child all day, but the moment you get home they have a complete meltdown. Your child screams, shouts, lashes out, sulks or generally acts in an unruly manner.


If that scene is familiar to you, you're not alone. This type of behaviour is what some psychologists refer to as 'after-school restraint collapse' and it's not unusual. It happens because your child has been busy managing their emotions all day as they navigate the complexities of school life.

When they get home, that's their safe space to let it all out!

So, now you know what it is, what can you actually do about it? Parents' Toolkit has been speaking to educational and child psychologist Dr Anisa-Ree Moses, for some tips on how to





Attendance

I have been asked a lot of questions about attendance recently and I would like to remind everyone about the importance of school attendance. Achieving high school attendance is a national priority. Chacewater school data clearly shows a correlation between high attendance rates and high achievement. We want our children to achieve excellent attendance in line with national average. Illness usually appears as a block of time off school. We review attendance patterns each week and look for unbroken and broken weeks as a key indicator. We would not usually expect that children would have more than one or two broken weeks in the course of an academic year. Regular broken weeks are a cause for concern and we will offer support to families where there are more frequent broken 6 weeks, in line with our attendance procedures. The impact broken weeks and missed learning can have on a child's education (taken from national data) is illustrated below for guidance:

If your child misses	That equals at least	Which is the same as	And over 13 years of education that's	Or at least
1 day a fortnight	80 lessons per year	4 whole school weeks per year	Nearly 1.5 whole years	1040 lessons
1 day a week	160 lessons per year	8 whole school weeks per year	Over 2.5 whole years	2080 lessons
2 days a week	320 lessons per year	16 whole school weeks per year	Over 5 whole years	4160 lessons
3 days a week	480 lessons per year	24 whole school weeks per year	Nearly 8 whole years	6240 lessons

As a school we follow the Truro and Penwith Academy Trust policy which can be found <u>HERE</u>. You will be aware that there have been a number of changes to the issuing of penalty notices and <u>there</u> is little or not discretion for headteachers regarding these. Attached with this newsletter is a leaflet about penalty notices but it is important to note:

What is a Penalty Notice?

A penalty notice is a fine that can be issued under section 444A and section 444B of the Education Act 1996. The fine is issued per parent, per child for:

- Leave of absence of 10 school sessions/5 days or more within any rolling 10 school week* period during term time, without authorisation from the school. This can include unauthorised absence for a holiday.
- Unauthorised absence of 10 or more sessions/5 days within any rolling 10 school week* period where a parent fails to provide an explanation for the absence, or where an explanation is provided but the school consider it insufficient to authorise the absence.
- Unauthorised lateness of 10 school sessions within any rolling 10 school week* period, whereby a child arrives at school after the registers have closed.

NB a penalty notice can be issued for any combination of the above reasons where there are 10 sessions/5 school days or more of unauthorised absence within any rolling 10 school week period. The unauthorised absence can be consecutive or non-consecutive and can span over two terms (including between academic years).

Please also be aware of the below:

If your child is absent from school without authorisation, you will be committing an offence under the Education Act 1996. We may submit a request to Cornwall Council for a Penalty Notice to be issued, in accordance with Sections 444A and 444B of the said Act. Penalty Notices are issued per liable parent, per child and each carry a fine of £80 if paid within 21 days or £160 if paid after this but within 28 days.

If your child is further absent from school without authorisation within any 3-year period, you will be committing a further offence under the Education Act 1996. We may submit a request to Cornwall Council for a Penalty Notice to be issued, in accordance with Sections 444A and 444B of the said Act. Penalty Notices for a second offence are issued per liable parent, per child and each carry a fine of £160, payable within 28 days.

Importantly, fines per parent will be capped to two fines within any three-year period. Once this limit has been reached, other action such as a parenting order or prosecution will be considered.

Failure to pay the Penalty Notice may also result in legal action. If you are prosecuted and attend court because your child has not been attending school, you could get a fine of up to £2,500. Cornwall Council may also apply for the costs incurred in taking the matter to Court, including legal costs.

Absence not authorised by the school may also result in a prosecution in the Magistrates' Court under Section 444(1) or Section 444(1A) of the Education Act 1996, leading to a fine of up to £2,500 and/or a custodial sentence. Again, Cornwall Council may also apply for the costs incurred in taking the matter to Court, including legal costs.

Money raised from fines is only used by the local authority to cover the costs of administering the system, and to fund attendance support. Any extra money is returned to the government.

Pupil Premium form etc.

As a school we are required to complete a census on Thursday 3rd October, this census drives our pupil funding.

The Pupil Premium Grant is additional funding that offers significant benefits to our students. As you may know, this funding is intended to help improve the educational outcomes of children from disadvantaged backgrounds.

The Pupil Premium is an additional sum of money given to schools for each child eligible for free school meals, those who have been in care, or children whose parents are in the armed forces. This funding is used to provide essential support and resources that can enhance your child's learning experience and overall development.

We need to conduct a search via the local authority on our pupils to establish eligibility for PPG.

Data will be treated with the strictest confidence and stored in line with GDPR regulations.

We appreciate your co-operation with this and would appreciate if you could complete this short form HERE by Friday 20th September at the latest.

Clubs



We have allocated places to both our key stage 1 and key stage 2 clubs. Wherever possible we have tried to ensure that every child has at least their first-choice of clubs. Clubs will begin next week. Please note that for football club the children do need football boots and shin pads. If you have any difficulty with this then please do let

us know. If you do have old unwanted boots or shin pads at home then we would welcome them as we try to keep some spares which we can lend out.

Harvest Festival – Please note the change in times



On the 15th October we will be holding two short harvest celebrations in Chacewater Church. One for reception and key stage 2 at 1.30pm and one for key stage 1 at 2.15pm. Parents and carers are welcome to attend these but please be mindful of available space in the church. During this week we will be taking a collection of goods for Truro Foodbank.
